1. Proposed annexation of 1.180 acres of land located on I-10 Service Road owned by Fulghum's & Hobson LLC

7. Discussion of and possible action on adopting Resolution No. 2020-010, a resolution authorizing execution of an Advance Funding Agreement (AFA) with the Texas Department of Transportation for a Transportation Alternatives Set-Aside (TASA) project.

Ricardo Villagrand presented to Council.

A motion was made by Councilman Peters to adopt Resolution No. 2020-010, seconded by Councilman Duree. Motion carried 7-0.

8. Discussion of and possible action on RFP for Compensation and Classification Study.

Calyn Wesson presented to Council. Top three were interviewed. Staff recommends Evergreen Consulting. Have been used in the past.

A motion was made by Councilman Pomykal to award RFP to Evergreen, seconded by Councilman McWilliams. Motion carried 7-0.
